

Questioning Transcript - Rockville Police Department

Dominic Carusi - Date: 12-21-1997 - Detective Mark Dole

1 **Detective Dole:** Can you please state your full name for the record?

2 **Dominic Carusi:** Dominic Carusi

4 **Detective Dole:** Can you also confirm your current residence?

5 **Dominic Carusi:** I live in the 8 Park Place on Park Ave

7 **Detective Dole:** Did you know Julietta Winston who lived in the apartment across
8 the way from you?

9

10 **Dominic Carusi:** Yes I did know her and I'm in total shock that this has happened
11 right where I live.

12

13 **Detective Dole:** How well did you know Julietta?

14 **Dominic Carusi:** Just normal neighbor stuff. I said hello how are you doing when I
15 saw her.

17 **Detective Dole:** Did you have any angry neighbor beefs with Julietta? You stole my
18 newspaper, your too loud or anything along those lines?

19 **Dominic Carusi:** No Nothing. I am at work most evenings and do not see her at
20 home that much.

22 **Detective Dole:** Where is it that you work?

23 **Dominic Carusi:** I work right at the Shop-N-Go down the road. Kind of a dead end
24 job but it pays the rent.

26 **Detective Dole:** Are you married?

27 **Dominic Carusi:** No. I have a fiancée. Someday we will get married but I guess not
28 until I get out of this dead end job or come up with some big money or big
29 inheritance. I have a good feeling it will happen soon.

31 **Detective Dole:** So on Friday between 10:30pm and 11pm where were you?

32 **Dominic Carusi:** I was working at the Shop-N-Go. In fact I worked the long shift
33 Friday night. 6 to 2am in the morning.

35 **Detective Dole:** That's a pretty long shift for a corner store.

36 **Dominic Carusi:** Yea it is a long shift, well I get a break halfway through which
37 helps but right now I'm just trying to get all the hours I can to make some extra
38 money and maybe someday get married.

40 **Detective Dole:** So when was the last time you seen Julietta?

41 **Dominic Carusi:** I saw her that same day at work. She was there with her
42 boyfriend. She came in bought some beer, played her normal numbers, just the
43 normal stuff people do in a corner store. Come to think of it. They did buy more
44 beer than normal. I figured she was having people over.

46 **Detective Dole:** So you have seen her with this man before?

47 **Dominic Carusi:** Yes. They have been in together before and I have seen him at the
48 apartments many times. One can only assume he is her boyfriend.

50 **Detective Dole:** So you said she was having people over. Does she do this a lot?
51 Like have parties?

52 **Dominic Carusi:** She has her fair share of get togethers or parties as you call
53 them, but like I said most of the time I am at work in the evenings and do not
54 get home until pretty late. I have seen people leaving when I get home in the
55 past at like 2 in the morning.

57 **Detective Dole:** So it would be plausible to say you may have been irritated with
58 her because they are partying and making noise in the early morning hours when
59 you get out of work and most likely want to sleep?

60 **Dominic Carusi:** No not at all. There are for sure times when they are loud, they
61 seem to argue a lot but nothing to give me a reason to be upset like that.

63 **Detective Dole:** So on that evening December 19th, you were working until the
64 following morning 2am, and when you got off work where did you go?

65 **Dominic Carusi:** I went home like normal and just went straight to bed.
66 It was a long shift and I was super tired. Passed right out.

68 **Detective Dole:** When you got home was there anybody going in or out of the
69 building besides yourself and was there any unusual activity or noises?

70 **Dominic Carusi:** I don't recall anybody. And no there was no noise or anything. I
71 figured the get together must have ended earlier if there even was one.

73 **Detective Dole:** Ok that will be all for now. I will be in touch with you if I
74 need more information.
