1 **Detective Dole:** Can you please state your full name for the record?

2 **Ronny Victorino:** My name is Ronny Victorino.

4 **Detective Dole:** Ok Ronny, where do you currently live?

5 **Ronny Victorino:** I live on South Clinton St.

7 **Detective Dole:** Do you work at the Park Place apartments?

8 **Ronny Victorino:** Yes. I work for the company that owns them. They also own a few  
9 other apartment buildings.

11 **Detective Dole:** Did you happen to visit or work on anything at this particular  
12 property yesterday at all? Were you there for any reasons at all?

13 **Ronny Victorino:** Umm I can't say that I recall being there at all.

15 **Detective Dole:** Really. Hmm. But obviously you have the key code to get into this  
16 building or any of the buildings?

18 **Ronny Victorino:** Yes of course. I have to work on them when the residents aren't  
19 home, sometimes they are home.

21 **Detective Dole:** Ronny I know that you know Julietta, because you have had a few  
22 disputes with her in the past according to her boyfriend Johnny. Can you tell me  
23 about that?

24 **Ronny Victorino:** She accused me of stealing stuff from her. One day she called  
25 me to repair her bathroom sink that was leaking. I fixed it and then the  
26 following day I showed up again to the other residents to repair his door hinge  
27 and out of nowhere she shows up and freaked out on me! Ask Johnny, he was there.

29 **Detective Dole:** So what was it that you stole?

30 **Ronny Victorino:** ahhh . . Nothing! I didn't steal anything from her.

32 **Detective Dole:** Ronny it's hard to believe that because your past history speaks  
33 for itself.

34 **Ronny Victorino:** Well believe it because I didn't. I'm telling you I didn't  
35 steal anything from her.

36 **Detective Dole:** You know what I think. I think you stole something from her and  
37 when she threatened to call the police or even the building manager. You knew  
38 that you would for sure lose your job or even spend some time behind bars.

39 **Ronny Victorino:** I didn't steal anything. I'm telling you I didn't. Why would I  
40 do something like that?

42 **Detective Dole:** Ronny come on man. I see this all the time. As soon as you  
43 realized that Julietta was gonna report you, you knew it would be her word vs.  
44 your word. And nobody would believe you with the history you have. This is total  
45 motive Ronny. Ronny you did something to Julietta.

46 **Ronny Victorino:** Listen, I know this little made up story of yours sounds like  
47 the perfect fit to pin me to this, but this is BS! I had nothing to do with this.

49 **Detective Dole:** So let me ask you this, where were you Friday around the time  
50 this all happened? 10pm to like 11pm.

52 **Ronny Victorino:** I was working. I worked all day and night Friday.

54 **Detective Dole:** Well Ronny let me tell you something. I will be looking into all  
55 of this. I will find out if you were really working. For your sake you better  
56 hope you were because stealing something so petty would be the least of your  
57 worries!

59 **Ronny Victorino:** I have nothing to worry about. You know what . . . Are you  
60 charging me with something because if not I'm done talking to you. Speak to my  
61 lawyer.

63 **Detective Dole:** Right now you're not being charged. You're free to go Ronny.  
64 As soon as I have what I need, I will be in touch with your Lawyer.
